The role:

- Fosters relationships with key internal stakeholders and partners within Providence Health Care, Vancouver Coastal Health and provincially.
- Key objectives include: establishing plans and strategies, goals and objectives; collaborating on budget and resource allocation and utilization; human resource management; quality of care and care delivery; quality management; academic and research activity.
- FRCP or CCFP qualifications are required.
- Member of the Providence Health Care Department of Family Medicine.

Services include:

- Engage family physicians and specialists for process development and implementation of Shared Care strategies and initiatives.
